WHEREAS, the Board of the School District desires to begin the procedure to sell the Main Campus Property and the Farm Property pursuant to applicable law, including O.R.C. § 3313.41; and

WHEREAS, the Board of the School District agrees that the Main Campus Property and the Farm Property are no longer needed for school purposes.

NOW, THEREFORE, BE IT RESOLVED by the Board of the School District that:

Section 1. The Board hereby authorizes and approves the procedures to sell the Main Campus Property and the Farm Property.

Section 2. The Superintendent, Treasurer, and/or Board President are hereby authorized and directed to do all things necessary and consistent with this resolution to accomplish the sale of the Main Campus Property and the Farm Property; provided, the that the final terms and conditions of any sale or other disposition of the Main Campus Property or the Farm Property, or any portions thereof, shall be approved by the Board prior to any transfer.

<u>Section 3.</u> The Superintendent, Treasurer, and/or Board President are authorized to pay reasonable costs incurred in connection therewith.
