Board Members

Mr. Taylor (Beavercreek) – Congratulated Mrs. Frantz on her 30 year Board member service award; Work continues on levy efforts with meetings and community outreach while work begins on a master facility plan as Beavercreek looks to add as many as 1500 students over the next 3 years and some buildings are already over capacity. 6.185 mill levy will be on the May ballot.

Mr. McQueen (Yellow-Springs) – School closed last Friday due to illness, 23% of middle school/ high school students were out; Nearing ready to select new Principal just as Superintendent search will get underway, and a Treasurer search may also be in the future.

Mrs. Callahan (Xenia) – Visioning committee continues their work, plan to make a recommendation to the Board in May. The group started with 27 presented options and have narrowed the list to 6 ½.

Mrs. Reagan (Greeneview) – Every day, full day kindergarten likely for next year; Community forum was held to consider a change to building structure. Board will make a decision on Tuesday, and will also start looking at master facility planning.

Mr. Uecker (Fairborn) – Walls are going up at Five Points; 178th Wing at the Springfield Guard Base operates Remote Piloted Aircraft. There is a need for pilots and technicians. The new GCCC programming will support these efforts.

Mrs. Martindale (Cedar Cliff) - Continuing to look into hiring an SRO. Everything else is calm.

Mrs. Frantz (Bellbrook-Sugarcreek) – Replacement levy on the ballot for May to generate an additional \$3 million per year of needed funds. One community member very actively working against the levy; Will be hiring a new principal and assistant principal.

Administrators

Ron Bolender, Public Information – It's competition season. Starting with BPA and DECA next week. When the season comes to a close, we will bring some of the State winners in to be recognized by the Board.

<u>Brian Hall, Technology</u> – Update on the Child Internet Protection Act, requirements, and the internet safety features we have in place.

Eva Anderson, Treasurer – Informed the Board of a new Community Reinvestment Area in Beavercreek.

Adult Education – The senior academy graduation will take place on March 15, 2019. The twenty-six graduates will sit for the Ohio Peace Officer Basic Training state exam on April 2, 2019. The junior academy will graduate on June 7, 2019; Both academies completed Community Service hours while assisting Texas EquuSearch on March 9th. The academy classes helped search for the missing Riverside woman, Cheryl Coker. They were able to learn first-hand techniques and procedures while working alongside Riverside Police and the Equusearch Professional Search and Rescue Team. Because of the student's professionalism and eagerness to help, they have been invited to assist in future search operations. The junior academy will be completing their final Community Service hours on April 27th as they assist the Greene Co. Law Enforcement Agencies with their Prescription Drug Turn-In Event. First Line Supervision training will begin on March 19th. Twenty-four officers will be attending the training. Correction Basic Training will begin on April 10, 2019. To date, thirty-four officers are registered for training. Fifteen agencies will be sending officers. Some of the agencies, such as Butler, Scioto, Highland and Mercer Co. Sheriff's Offices, will have a long commute to attend; Two 2018 graduates were sworn in this month at the Greene Co. Sheriff's Office and Xenia Police Department.

<u>David Deskins, Superintendent</u> – Recognized Mrs. Frantz's 30 year commitment to serve on the Board; Greentree Group will be awarded our partner in education at the Beavercreek Chamber event; Mr. Uecker will receive the Friends in education award for the Fairborn Chamber; Attended a community meeting hosted by City of Xenia; Update on potential new business to locate near our new site.
