- Mr. Deskins, Superintendent: Time capsule for new site to be filled in the next few weeks; House on new campus site will
 need to be demolished; Airport project well underway. Metal structure up and temporary heat expected in two weeks; Main

Adult Education Updates:

- Fall Peace Officer Academy has 25 students remaining in the class, one was hired by the Federal Government (Border Patrol). Graduation is March 13th. The graduates will be taking the Ohio Peace Officer Basic Training state exam on April 14, 2020.
- Winter Peace Officer Academy has 13 students remaining in the class. One individual dropped due to an injury.
- We are hosting the Greene County Law Enforcement luncheon on February 20th in the Howard Conference Center.
- The last correction academy test results came in and we had 100% pass.
- In addition to POBT, we have several upcoming training sessions:
- FTO: Twenty-five officers are registered to attend the Field Training Officer course that begins March 2nd. These officers will be responsible for providing "In the field" training to newly hired officers at their respective agencies. Most agencies require new officers to participate in 14-20 weeks of FTO training before patrolling on their own.
- First Line Supervision training will begin on March 16, 2020.
- Correction Basic Training will begin on April 14, 2020.
- Probation Training is ongoing
