- Mr. Taylor, Beavercreek Slow in the summer, however, community engagement continues. Police Department reinstituted Safety City for preschoolers; Still recovering from tornado damage. 150 students are displaced and 47 structures totally destroyed. The community has come together in supporting those affected.
- **Dr. Callahan, Xenia** Soliciting suggestions on the six building plans that were presented.
- **Mr. McQueen, Yellow Springs** Negotiations are not yet completed, not going as smoothly as in the past. Hope to be completed in August; New position for Director of Athletics being posted to encourage athletic participation.

- **Mrs. Reagan, Greeneview** –New middle school principal; Revised code of conduct and discipline policy was approved last meeting; Special Board meeting week before last to review classified negotiations; Plan to fill all remaining positions for next school year at tomorrow's meeting.
- Mr. Uecker, Fairborn Five Points building construction continues; Things are going well in Fairborn.
- **Mrs. Martindale, Cedar Cliff** –Negotiations start later this month; Building repairs through the summer getting ready for the start of school.
- Mrs. Frantz, Bellbrook –Due to the levy failure the Superintendent has made the first round of cuts. Transportation is the first area to be affected. Bussing will now be 1-mile out for high school and middle school. Third Twelfth grade students will ride together on one route; Survey of community around levy failure determined support for the schools but an willingness to increase taxes.

Adult Education Updates

Throughout June and July, the academy is on summer break and operating under limited office hours; however, academy preparations are well underway. On June 25, 2019, twenty—two graduates successfully passed the OPOTA Peace Officer State Exam. One remaining graduate will test on July 25, 2019. There are currently 20 Peace Officer Basic Training students registered for the September 16, 2019 academy. The registration process will continue into September. The second POBT academy will begin on December 2, 2019. There are two Correction Basic Training academies scheduled for the 2019-20 school year- one beginning in October 2019 and the second beginning in April 2020.
