\*If you are rostered on a high school Baseball or Softball team you are eligible to play county ball unless you have received a Varsity letter for the 2023 season. Registration still needs to be completed during normal registration times and dates. No refunds will be given after registration is complete.

## COSTS FOR THE 2023 SEASON:

The registration fee will be **\$75.00 per player**, with a maximum of \$180.00 per immediate family (children residing at the same address). Payment in full is due at the time of registration. If a player registers **after February 19th**, there will be a **\$20.00 LATE FEE** per player added to the \$75.00 per player registration fee. **There is a returned check fee of \$30.**

Unless additional players are needed to fill rosters in a certain age group, no late registrations will be accepted after 2/28/23. Except in extraordinary circumstances, we cannot make exceptions to this rule, as we have to decide how many teams we will field in each age group and how many players will be on each team prior to the draft. Exception requests for late registrations will not be accepted after teams are formed.

Registration fees cover costs including but not limited to the following: team uniforms (shirts and hats), coaches' shirts and hats, equipment, umpires, field preparation costs, game balls, score books, copy supplies, and tournament fees.

Team shirts and hats (hats for Boys, hair bands for girls) will be provided. Each player will provide his or her own baseball pants/softball shorts, socks, etc.

## SCHEDULE FOR THE 2023 SEASON:

Registration will take place in early February, rosters will be completed in March, and practices will commence on around the 1st April. Regular season games will commence in May and June, and post-season tournaments concludes by the beginning of July.

**\*All new players and any players that do not wish to play for the same coach who coached his or her previous year's team will be placed into the draft pool and may be drafted by any team with open roster spots to fill. With the exception of players returning to the same team for which they played in the previous year, there is no guarantee that any player will be placed with a certain coach/team, and there is no guarantee that a player who elects to go into the draft pool will not be drafted by his or her previous team. The board has the right to move a child to a team and not place him in the draft if the board sees fit. The player draft will be closed to coaches and the board shall fill all teams to the best of their abilities. There will be no refunds of registration fees after the teams are formed.**

CONSENT/NOTICE: If my child becomes ill or is injured during any practice or game and requires medical attention and I (parent/guardian) am not present and cannot be reached, I hereby authorize the PBSA or its agents to obtain medical treatment deemed necessary for the well-being of the child. In the event that I cannot be contacted, my signature below gives full authorization for the administration of any treatment deemed to be necessary by a medical practitioner, the transfer of my child or ward to any medical practitioner, and the transfer of my child or ward to any licensed hospital or emergency clinic reasonably accessible. It is understood that this authorization is given in advance of any specific diagnosis, treatment, or hospital care that may be required, and it is given to provide authority and power on the part of the PBSA and its agents to obtain reasonable treatment/care. I understand that after my child is assigned to a team, it will be my responsibility to notify my child's coach about how I can be contacted in the event of an emergency and about any noteworthy information concerning the child's health (including but not limited to allergies, medications being taken, any physical or mental conditions) about which his or her coach should be aware.

INDEMNITY AND WAIVER: I hereby certify that I am the parent and/or legal guardian of the above-named applicant, and that I have thoroughly read all of the above.
