Sound Innovations



The purchase of a soundboard, microphones and a tablet, the vocal music department has been able to raise the quality of our technology to match the facility. This has also enabled us to further assist the student's basic needs in a music education environment.

Much of our technology has been unusable for several years due to the lack of a working sound panel and

wear of aged technology. The new equipment allows for return of full functionality to the hardware and technology built into the room.

The speakers are able to be utilized from the computer, bluetooth from the tablet, as well as act as a make-shift interactive recording studio for students to instantly record and reflect on their performances.



Cookbooks

Mrs. Householder's 2nd grade classroom wrote, published and purchase 19 cookbooks.

This project was a way of building community in the classroom and allowing all students to represent their family and culture. Students brought in a recipe of their favorite home cooked meal. They shared their recipe with their classmates then copied the recipe into a classroom cookbook.


Students illustrated their recipe to showcase the meal and how it is prepared at their home.

Pizza Plushies

This grant allowed for the purchase of art supplies to study and create textile pizzas with the 5th grade art students at Claymont Intermediate School.



The students learned about textile artists and created pizza that was hand sewn. They collaborated with the high school art students who created pizza boxes to display the pizzas.

This art lesson allows the students

to create a fun 3D piece of art and learn an important life skill. The students had a great time creating this unique project.

Teacher and Building Grants Reports

Auditeria Sound System Upgrade

Phase I of the new stage and auditeria sound system upgrade are falling in to place. The new wireless microphones were installed weeks before the Spring Musical, Mamma Mia.

The upgrade includes cordless microphones, sound mix board, microphone stands, new speaker and better overall sound control in the auditeria.

This upgraded sound system will benefit the arts programs at Claymont, as well as other school and community events



Curtains for Auditeria

Claymont High School was awarded a grant for the Auditeria curtain replacement project. Through additional funding of a local family and a gift from the Drama Department, the entire project has been funded.

Due to slowed production of the curtains, and the refinishing of the stage floor this summer, the curtains will be replaced following the refinishing and will be in place by the first day of school.

High School Sensory Room



This grant allowed the High School Building to provide a more diverse and useful sensory experience to the students. They were able to purchase: an Alexa, reusable wall covering, chairs, lights, ceiling light covers, timers, and multiple sensory mats and tools for the students.

This space provides the students a quiet, private space to collect their thoughts and calm down. This room has also provided our Physical and Occupational Therapists a spot with several tools to help diversify student therapy.







Music of the Wild Canton Symphony Kinder Concert

The Canton Symphony Orchestra and Stark Parks came together to produce a collaborative concert that educated students about music through nature at the Canton Cultural Center for the Arts. The Kindergarten students were able to hear a live orchestra and see live animals. Owls, birds, turtles, a snake and even a skunk were shown to the students.



They learned about the animals and listened to music that went in tandem.

Students heard music by composers such as Beethoven and Debussy. The Kindergarteners enjoyed getting to hear and see string, woodwind, brass and percussion instruments up close.

Multicultural Art

Multicultural art gives the students an opportunity to explore their own personal cultures and those of others. The students were able to create Mardi Gras masks, Antoni Gaudi's Spanish mosaics, Stephanie Shih's Asian inspired ceramics, Van Gogh's Dutch line art, and so much more.

The students enjoyed learning about all these different cultures and using different art mediums to create each project. These projects engage the students and create cross curricular teaching opportunities. They will continue learning about different cultures in art for years to come.







Ceramics

Ceramics for college and beyond allowed for the purchase of high-fire clay, glazes, and under glazes. With this clay, the upper level art students were able to build bigger and more sturdy projects. With the higher fire temperatures, the projects will last longer and be more durable and resistant to chipping.

Ceramics III students began using this clay by building two feet tall historically based vases and used a clay extruder. The resulting work was outstanding.

The new glazes have more color variances and are of a higher quality. The students have made stacking dolls and dinnerware sets that they made with these new materials.

Ceramics II built Chia pets that are in the shape of shoes. They were able to mix the white and the brown clay to create their shoes. These shoes aren't able to be glazed in order for the Chia pets to work well. With the addition of the brown clay, they were tasked to add this color in a way that was interesting and worked well with their design. As soon as these projects are fired, they will be ready to plant and will be ready to 'plant' soon.





KILN

The 1st and 2nd graders at the Elementary building were able to purchase a kiln to fire their clay art projects.

Clay is one of the mediums that teaches students to be creative. Clay also improves students' hand/eye coordination while also building both fine and gross motor skills and is perfect for sensory development. Having access to a kiln at the Elementary building will enable the students to have more opportunities to do ceramics.

"Class Act" Performance series at Kent State University

Claymont Intermediate Students ventured outside the classroom and had an opportunity to represent the Claymont School District at Kent State University's Performing Arts Center. In addition, the students experienced going to a live, professional theater performance where they utilized the soft skills needed for appropriate social behaviors in a public setting.

Fourth and Fifth Grade students watched Full STEAM Ahead with Mister C, which focused on science inquiry and the application of the inquiry process.

Third Grade students watched A Seussified Christmas Carol, reinforcing third-grade literature standards.





9 Square in the Air

9 square in the air is a game that blends the skills of volleyball and 4 square together to make a fast moving game that can be enjoyed by many students at one time. The game was not only used at the middle school with grades 6, 7, & 8, but because it is portable and adjustable it was able to be taken to the intermediate school where grades 3, 4, & 5 enjoyed playing it as well.

STEAM PUNK ROBOTS



Students in the 4th grade learned about Steam Punk Art and then created their own Steam Punk Robot sculptures.

Steam Punk art is a retro futuristic subgenre of science fiction or science fantasy that incorporates technology and aesthetic designs inspired by 19th-century industrial steam-powered machinery. It is also a cultural movement inspired by the Industrial Revolution.

Students learned how to mix modern ideas and technology with those of the past as they explored the features of this art movement in their own art making process.

VOX Reading Program

The Learning Loss Recovery collection from VOX includes a series of fictional books that will grab students' attention and engage them into text.

The VOX reader that is built into the book eliminates the barrier that nonreaders and emergent readers face when getting curious about text because the technology reads the text for them. These books are used as a daily learning center in the first grade classroom.


Students can independently 'read' while the teacher engages fellow classmates in small group lessons and works the class through rotations. While teachers are aware of the benefit of small group instruction it remains a challenge to keep four to five small groups of children engaged in small group activities while working with one group at a time.

Vox books enable children to receive exposure to high quality text in the cozy environment of the classroom library while in their small group ahead of the time they meet with their teacher.

DOCUMENT CAMERA

With the purchase of this document camera, each of the art classrooms now have a document camera for teaching and demonstrating. Since young students are still developing their drawing skills, they need visuals and demonstrations.

The Document Camera provides students access to see guided demonstrations, introduction of skills, examples, and read-aloud documents up close. It provides a bird's eye view and projects the image onto the white board for every student to see.





Primary Sensory Room

The grant awarded to the Primary Building sensory room allowed the building to provide a more diverse and useful sensory experience to the preschool and Kindergarten students.

They were able to purchase a Crash Pad, Ball Pit, Table and Chairs, a wall sized Sensory Crocodile, light filters, multiple types of fidgets, blankets, balance beam and multiple light up sensory toys. The students love the time that they are able to calm down in the sensory room and get back on track for the day.

This room has also provided our Physical and Occupational Therapists a spot with several tools to help diversify therapy.









Plant Journal Project

The students created a Plant Journal to record plant observations, complete plant research and use their creativity to explore various of plants.

First the students received a plant journal booklet, colored pencils, mechanical pencil and various plant stickers to begin their plant journal cover and booklet. Next, the students planted Zinnias and Wildflowers in separate containers in order that they may observe plant growth. Students then began journaling plant observations along with research on their favorite plants, wildflowers and houseplants. They used their creativity to draw plant pictures along with poetry writing about plants.

Turtle figurines were placed as decorative pieces in the Zinnia containers and were given to Moms on Mother's Day. Mushroom figurines along with butterflies will be placed in the Wildflower containers to be taken home at the end of the school year.

The students have enjoyed this project and look forward to examining their plants daily for growth. This English and Language Arts (ELA) project is an excellent writing tool for the classroom. Also, as a cross curricular project it has been educational and a fun way to incorporate science and math into ELA.

Spongebob: The Musical

The 2nd grade students were all able to attend a performance of Spongebob: The Musical at the Players Guild Theater in Canton, Ohio.

This Tony Award nominated musical portrays the story of Spongebob, Patrick and Sandy working together to save Bikini Bottom from imminent destruction. Squidward, Mr. Crabs, Plankton and many other beloved characters also appeared in the musical.

The students loved the show. Exposing students to high level musical theater, live performances and theater is an integral part of music education.





Marvelous Music Carpet

The Music Activities Carpet is a progressive and highly valuable tool for teaching music at the Intermediate School. Included on this carpet are several musical concepts that are absolutely key to the development of strong musicianship and independence, which are aligned with Ohio Music Education Standards. These include: Kodaly Solfege syllables, one octave of piano keys, treble and bass clef, eight different rhythmic units, and one large circle used for circle games. This carpet has been a wonderful addition to the classroom.
