From Sara Colver, 4C for Children

From Dr. Laurie Dinniebiel, Ohio Center for Autism and Low Incidence

- The Ohio Center for Autism and Low Incidence is dedicated to fostering high quality inclusive child care for children with disabilities.
- It provides resources for early learning professionals at www.cycsuite.org. All of the learning modules, which can be completed online at your convenience, are Ohio-approved.
- Laurie recommended "We can do this right where we are" an introduction to evidence-based models that support inclusion. This module takes 75 minutes to complete; participants receive 1 hour of Ohio-approved credit.
- OCALI also offers certification on working with toddler and preschoolers on the autism disorder spectrum.
- Find seminars focusing on children from birth to 3 at www.cycseminars.org.
- This year's OCALIONLINE conference is Nov. 16-19. There will be sessions related to children with all manner of disabilities not just autism.
- OCALI also supports families of children with disabilities not just educators. Please tell your families about the organization.
- Another valuable resource is the <u>Early Childhood Technical Assistance Center</u>. Its resources are in English and Spanish and include performance checklists. Its trainings are not Ohio-approved. Training topics include arranging your classroom, how to modify centers and make adaptations, and helping families build their capacity. There also are trainings around instructional practice, including practice guides for teachers and families.

Ohio has raised the eligibility limit for receiving PFCC to 142% of the Federal Poverty Level.

- The eligibility cutoff for children with disabilities has been increased to 150% of the Federal Poverty Level, up from 130% of FPL.
- To be a PFCC provider, programs must sign a provider agreement and participate in *Step Up to Quality*.
- Children can qualify for PFCC support until age 13 up to age 18 if the child has a disability.

- Transitional Pandemic Child Care Rules-While programs are no longer required to follow transitional pandemic child care requirements, they should follow all guidance from the Centers for Disease Control and Prevention (CDC). Please use the following link to access updates and information; COVID-19 Guidance for Operating Early Care and Education/Child Care Programs (cdc.gov)
- **Temporary Pandemic School Age Child Care Centers**-Programs with this type of license ended June 30th. If providers want to continue caring for children, they must submit an application and complete the application process in order to resume care.
- **Budget Updates** The 2025 requirement to be highly rated and the benchmarks have been removed. A committee is being established to evaluate PFCC and SUTQ. Eligibility for PFCC is being increased to 150% for special needs children and 142% for all families.
- **Technical Assistance (TA)Calls/Visits-**In light of pandemic challenges, licensing specialists were unable to complete technical assistance visits the past year. We will resume TA this fiscal year. If your specialist contacts you to set up a TA call/visit, please take advantage of the opportunity to help maximize compliance with licensing rules and SUTQ program standards.
- Administrator Rules Training-In order to meet the high demand for administrators who need to complete the rules review course, we will be offering more part 2 sessions between August and December. Please be sure to check the OPR weekly to register for a session. Please don't register for more than one session. If you are unable to attend the session in which you have registered to attended, be sure to cancel your registration if you are unable to join the training. The invitation/appointment to join the training in Microsoft Teams is sent via email (the email address associated with your registry profile). The invitation/appointment will be sent 2-7 days prior to the training date.
- **Five Year Licensing Rule Review** Be on the lookout for the two five-year rule review packages due later this year. Review them carefully and reach out to licensing staff if there are any questions about changes or new requirements.



- Professional Development (PD) Certificate-According to the trainings verified in the Ohio Professional Registry (OPR), you have at least one employee in a Step Up to Quality (SUTQ) role (Administrator, Lead Teacher, or Assistant Teacher) that requires a Professional Development (PD) Certificate who did not obtain their PD Certificate for the last biennium ending June 30, 2021. As a result, your program's SUTQ rating is in jeopardy of being removed. Due to the COVID-19 pandemic, an extension for applicable staff to obtain their PD Certificate is being granted. In order to maintain your SUTQ rating, the employee(s) who did not meet the PD Certificate requirement are required to obtain their PD Certificate for the current biennium by Sunday, October 10, 2021. Your first action should be to confirm all employees for your program are current employees and have the correct roles. If there are any employees linked to your program who are no longer employed, unlink them from your program. If the professional has multiple OPR profiles, that may also affect the PD Certificate and the OPR will need to be corrected. - Dayton Field Office Staff Changes-Five licensing specialists retired in our office from July 2020 to June 2021 (Michele Miller, Chris Peterson, Sharon Shelton, Cathy Linquist, and Susan Purvis). We have hired three new specialists, Carlie Bennett, Nicole Vadnais, and Steffani Roberts. We are in the process of hiring two more new specialists.
- Hero Pay- In December 2020, Congress passed the Coronavirus Response and Relief
 Supplemental Appropriations Act of 2021. The Act provided Ohio with funding to help support
 the child care workforce. Early childhood professionals who worked in an eligible role at a child
 care center, type A home or type B home licensed by the Ohio Department of Job and Family
 Services (ODJFS) may be eligible to receive Hero Pay.
- One-Time Pandemic Support Payments- Child care programs may be eligible for financial support to help with operation expenses related to impacts of COVID19. Applications were not required, and payment processing began the week of July 19th.
