

CARES Act (HEERF II) Emergency Relief Fund

Higher Education Emergency Relief Fund (HEERF II) Student Portion Allocation for ONC BOCES Practical Nursing Program

1. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

ONC BOCES Practical Nursing Program acknowledges that the school has signed and returned to the Department of Education the Certification and Agreement for CARES HEERF II Emergency Financial Aid Grants. ONC BOCES Practical Nursing intends to use no less than 50% of the funds received under Section 18004(a)(1) of the CARES Act (HEERF II) to provide Emergency Financial Aid Grants to students.

2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.

ONC BOCES Practical Nursing Program received \$27,027.00 for Emergency Financial Aid Grants to Students.

ONC BOCES Practical Nursing Program has disbursed \$24,484 in Emergency Financial Aid Grants to Students under Section 18004(a)(1) of the CARES Act (HEERF II).

ONC BOCES Practical Nursing Program determined there were twenty-one (21) eligible students under Section 484 in Title IV of the Higher Education Act of 1965.

We have currently awarded twenty-one (21) PN Students emergency grant awards.

6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act.

ONC BOCES Practical Nursing Program determined that the HEERF II Emergency Financial Aid Grant funds would be distributed to all PN Students with need. We have calculated funds based on need awarding more to the highest need students and working downward until all funds are awarded to students.
