TITLE ONE PARENT AND FAMILY ENGAGEMENT POLICY

W. R. Croman Primary School 2023-2024

Purpose

The Board recognizes that meaningful parent and family engagement contributes to the achievement of state academic standards by students participating in Title I programs. This policy, developed by W. R. Croman Primary Elementary in collaboration with and agreed to by parents and family members, describes how parents and family members will be engaged at the school level.

Components

The school complies with federal law related to the engagement of parents and family members by detailing how the school will:

- 8. Involve parents and family members in the joint development of the Schoolwide Program Plan in accordance with federal law. (Note: applies only to Title I schools operating a Schoolwide Program).
 - Parents are invited to EOY planning meetings for next school year decisions.

- 9. Create a school-parent and family compact developed jointly with parents and family members outlining how parents and family members, the entire school staff, and students will share in the responsibility for improved student academic achievement and the means by which the school and the parents and family members will build and develop partnerships to help children achieve the state's academic standards.  of their children and positive use of extracurricular time and

- Address the importance of communication between teachers and parents and family members on an ongoing basis through, at a minimum:
 - Teacher conferences with parents and family members in elementary schools, at least annually, during which the compact shall be discussed as the compact relates to the individual child's achievement:
 - a. Scheduled conferences occur once in the fall and the spring. They are also available at the request of parents.
 - Frequent reports to parents and family members on their children's progress:
 - b. Three times a year for report cards and four for progress reports.
 - Reasonable access to staff, opportunities to volunteer and participate in their child's class, and observation of classroom activities; and ensuring regular two-way, meaningful communication between parents and family members and school staff, in a language that parents and family members can understand.

Delegation of Responsibility

The Superintendent or designee shall ensure that the Title I Parent and Family Engagement Policy, plan and programs comply with the requirements of federal law.

- 1. An explanation of the reasons supporting their child's selection for the program.
- 2. A set of goals and objectives to be addressed.

- 4. A copy of this policy and the School Parent and Family Compact.
