

## GREENE COUNTY Admissions Process 25-26

	Priority Admission
Admissions	<b>December 6th through January 9th</b> Priority consideration is given to incoming juniors residing in a member school district in Greene County and applying for full-time status. Students meeting eligibility & living in a member district but attend school elsewhere will be placed on a waitlist until confirmation of enrollment in member district. Traditional homeschooled students must return a Homeschool Contract.
Timeline	Rolling Admission
	Students applying after January 9th will be admitted upon order of applications received, as availability allows.
Direct Admit	<ul> <li>Students should be on track to have the following required credits by the end of the sophomore year: <ul> <li>Math: 2 credits required</li> <li>English: 2 credits required</li> <li>Social Studies: 2 credits required</li> <li>Science: 1 credit required, 2 preferred</li> <li>Health/PE: 1 preferred</li> <li>Minimum of 8 overall credits (10+ preferred), with at least the required courses above, by the end of the sophomore year</li> </ul> </li> </ul>
Pending	Students with 7 credits (or missing 2 of the above required credits) at the end of the sophomore year, will be placed on a pending plan (see additional admissions criteria below).
Non-Admit	Students with less than 7 credits (or missing more than 2 of the above required credits will not be admitted to the career center due to unfeasibility of attaining graduation with limited scheduling options at GCCC. Students can still have access to CTE at their district.
Attendance	<ul><li>85% attendance record in the prior school year required for:</li><li>Cosmetology</li><li>Health Science</li></ul>
Admissions Process	<ul> <li>Programs with over-enrollment of Direct Admit students as of the January 9th, will have a lottery for available seats - students will be randomly ranked and the first 25 will be selected. The ranking will hold true for the waitlist, if applicable.</li> <li>Direct Admit students not selected for the program in the lottery will be placed in their 2nd choice if there are available seats, while remaining on the waitlist for their first choice.</li> <li>Pending Students will be admitted once they have completed the Pending Plan, they are approved by GCCC, AND there are open spots in a program in the rolling admission timeline.</li> <li>If both 1st and 2nd choice are full, Direct Admit and approved Pending students can choose a 3rd program that has available openings.</li> <li>Direct Admit and approved Pending students can choose to be placed on a waitlist for their 1st choice program.</li> </ul>
Miscellaneous	<ul> <li>After the application closes, families with extenuating circumstances can contact GCCC about enrollment. Consideration will be on a case-by-case basis as availability allows and if approved by the Director of Secondary Education.</li> <li>Students currently enrolled at GCCC but transferring programs (only to a 1st year program) will be placed in the rolling admission timeline.</li> <li>Students who are deferring admission will be placed in the rolling admission timeline.</li> <li>GCCC shall comply with all applicable state and federal laws and regulations pertaining to the admission of students with disabilities. Final acceptance for admittance for a student on an IEP will be determined after an IEP transition meeting is convened with a GCCC representative in attendance.</li> <li>For additional questions, please contact admissions@greeneccc.com.</li> </ul>
