ENROLLMENT PACKET

PRIOR TO ENTERING THE PROGRAM

1. The student will have completed required pre-entry assessment including successfully securing a level 3 in workplace documents, applied math, and graphic literacy. Review fractions, decimals, percents, division and multiplication. Cost \$75
2. Each student will be required to show proof of a recent physical examination by your physician and documentation of a 2 step TB test, or chest x-ray *prior* to the STNA orientation dat. Documentation of examination and testing must be within one year of the start of class.
3. Students will be given a form for the physical, and 2 step TB during the Informational Session.
4. During Information Session each student will be given a list of The State of Ohio Senate bill 160 Ohio Revised Code Disqualifiers. Each student will be required to sign off on The State of Ohio Senate Bill 160 Ohio Revised Code Disqualifiers.
5. Attend Orientation Session.

Uniforms

Uniforms are required for the classroom, laboratory and clinicals. A deduction of five points will be taken off daily for inappropriate uniforms and/or appearance. These points will be averaged in with other grades. The proper uniform is as follows:

1. Appearance should always be in good taste. Good hygiene should always be practiced.
2. Navy scrub tops and bottom (no sweats, stretch pants or jeans).
3. Solid color shirts may be worn underneath the scrub top.
4. Clean tennis shoes/shoes – mostly white or solid dark color
5. Nametags will be supplied by the school and will be considered part of the uniform.
6. Hair should be neatly arranged away from the face. Scarves and patterned head bands are not permitted. Head covering exceptions will be determined on an individual basis. Mustaches and beards must be neat and well-groomed.
7. Excessive jewelry is not permitted. One small ring or wedding ring may be worn.
8. Artificial nails are not permitted. Nails must be short.
9. Facial piercings are not permitted at clinicals.
10. Tattoos, when possible must be covered.

AFTER ENTERING THE PROGRAM

1. The student is expected to have **100%** attendance for the over-all program.
2. The student is expected to have **100%** attendance in the clinical portion of the program.
3. Absences in emergency cases:
 - a. must be made-up
 - b. unable to make-up missed time will result in termination from the current program with the opportunity to makeup time in the next class
4. A deduction of five points will be taken off daily for inappropriate uniforms and/or appearance. These points will be averaged in with other daily grades.
 - a. deducted points will be reflected on the rubrics scores for the **classroom** midway and on the final day of the course.
 - b. deducted points will be reflected on the rubrics score for two days of **clinical**s.
 - c. rubrics score will be averaged in the overall grade.
5. The student must maintain 80% grade average.
6. It is the student's professional responsibility to attend class.

CLINICALS

All students are required to complete an *unpaid* clinical for the successful completion of their program. These hours are completed under the direction of medical personnel and will be adequately supervised.

A clinical evaluation report is required of each student upon completion of hours. This evaluation will be a pass/fail endeavor.

Content in our classroom and skills lab includes communication, personal care, infection control, safety, legal implications, basic emergencies, body mechanics including ergonomics and OSHA algorithms, basic nursing and restorative care. Students learn the latest trends and practices with a hands-on approach.

Graduates of our 90-hour training course are eligible to take the Ohio STNA exam if all program criteria has been met.

NURSE AIDE TRAINING AND COMPETENCY EVALUATION PROGRAM

1. Students evaluated daily.
2. Must pass skill performance check-offs 80% or higher.
3. Maintain 80% grade average or higher.
4. Pass State Test (80% or higher – Skills portion & 75% or higher Written portion).
