### Superintendent's Report

Transportation Director Kelley Linzie provided an update regarding transportation routes as they will impact this school year. Transportation is facing a very challenging time due to the driver shortage, along with the number of students vs. routes that are driven each day. Ms. Linzie and staff have been working tirelessly to recruit new drivers every day to assure the safety of all students. She is very thankful for all their hard work, efforts and dedication.

Dr. Anstadt provided an update on COVID numbers from the first 10 days of school.

- 42 Positive students (1st-12th grade)
- 6 Positive Staff
- 209 Quarantined Students
- 3 Quarantined Staff

Dr. Anstadt emphasized that there are some schools that have positive cases and some that do not, however it took six weeks last year to reach the same positive numbers. The number of quarantined students is the second highest number yet. The most stark difference is the number of positive students. Our trends mirror the national trend of exponential cases among children. Further, Dr. Anstadt mentioned a letter will be distributed to all Washington Local families from local pediatricians and pulmonologists giving good counsel regarding Covid practices such as masking and vaccinating, as they are the people families have trusted for years, confirming what we are doing as a district.

#### **Board Discussion**

Legislative Update - Mrs. Mayfield provided the following information.

- The State Board of Education appointed Stephanie Siddens as Interim-State Superintendent until the end of the month when a permanent superintendent will be selected.
- HB 248 Vaccine Choice & Anti-Discrimination Act on hold. This act affects a lot of the things we talk about regarding Covid. It would block public agencies, schools, daycare providers, and others from requiring or asking someone to get vaccinated against Covid or any infectious disease.

-Governor DeWine has spoken against this bill.
