Mr. Covert (Legislative Liaison) discussed the following:

- 1. SB 240 Teacher Evaluations. OEA strongly supports SB 240. The bill contains comprehensive reforms to the Ohio Teacher Evaluation System (OTES). This bill would rebalance and restructure OTES so that evaluations are teacher-driven and student focused.
- 2. HB 271 Taxes on Unsold Property. This bill would exempt from property taxation the increased value of land subdivided for residential development until construction commences or the land is sold.
- 3. The Athens County Commissioners are in the process of adopting resolutions to establish a County Land Reutilization Corporation (CLRC), also known as a land bank. The land bank can demolish blighted properties and repurpose vacant land.

Mr. Depoy stated the Athens-Meigs ESC will offer a seminar for new board members on January 31, 2018.

Mr. Nottke asked if there could be instructors at each board meeting to speak about their program.
