





PROVIDER TYPES



MDLIVE has the largest national virtual behavioral health network of 600+ NCQA credentialed providers.

There are two types of BH providers:

Non-MDs/Therapists

- Master's-prepared clinicians
- Licensed Professional Counselors (Marriage and Family Therapists)
- Licensed Social Workers
- Psychologists

*Important Note: Therapists only provide talk therapy; they do not prescribe medications.

MD/Psychiatrists

- These providers primarily prescribe medications for behavioral health conditions.
- MDLIVE physicians are allowed to refill prescriptions for a member up to a total of 3 times per 12 months, but no more than 2 consecutive months.
- Note that this requires an additional consultation after 30 days, and does NOT allow for a refill of 60 days on any refill request.
- Providers may limit the supply based on state regulations, if applicable.

CLINICAL SUMMARIES POST CONSULTATIONS



Members have the ability to send information to their PCP; however, members can actually designate any provider by inserting the providers information and fax number in the same area of the MDLIVE platform.

The clinical summary is sent via secure fax.
