District 23 Return to Full Remote

Spanish Translation

Dear Parents and Staff,

District 23 will return to Full Distance Learning 2.0 for ALL students starting next week. At this point, January 19 is our next realistic return date, but we will continue to monitor data and bring Targeted students back on campus, or even hybrid, as soon as possible. Unfortunately, case and positivity rates continue to rise and we have surpassed our ability to maintain a safe teaching and learning environment.

We are aware of 5 staff members, 7 students, and numerous family members who are currently confirmed COVID cases. There are many cases of close contact among students and staff due to the widening spread. I'm certain that there are more cases that have not been reported to the schools. At present, we have excluded more than 20% of staff and and 5% of students due to various COVID related factors.

We keep our staff, students, and their families who are coping with COVID and its symptoms in our thoughts and prayers, wishing them all a speedy and full recovery. We continue to report to the Cook County Department of Public Health and ask everyone to please participate in their contact tracing efforts.

We recognize and share in the disappointment of not being in person for instruction, but have an obligation to our students, staff, and community to do our part to stop the spread of the virus.

As we return to our remote instruction model, our pledge is to continue to provide a robust, rigorous, and highly engaging program. The transition from Fall to Winter, including the holiday season, will present both challenges and opportunities for all of us, so we must continue to work together to make the best of this situation. We must redouble our efforts to maintain our mitigation efforts: wearing masks, keeping socially distanced, and continued hand washing.

I am hopeful that our efforts, as part of a larger communitywide response, will help keep everyone safe and enable us to return to in person instruction safely.

Lastly, as we gather (physically or digitally) with friends and family to celebrate Thanksgiving, I will keep the Community of District 23, students, staff, families, and partners on my list
