## Waiver of Liability for the CVCS Color the Valley Run - September 17, 2022

I agree to waive and release any and all claims I may incur against Charlotte Valley Central School, all of their employees and volunteers, along with any and all officials and sponsors of this run, for any and all damages, or other liabilities suffered by me which might result from my voluntary participation in this run. This waiver and release shall be binding upon me and upon my executors.
