#### **Board Members:**

Mrs. Gillaugh (Cedarville) – Cedar Fest went well. Superintendent is hosting "Super Lunches" with the 5<sup>th</sup> & 6<sup>th</sup> graders. Current facility projects include sidewalk improvements and installation of a new automatic egress gate

Mr. McQueen (Yellow Springs) – Construction is expected to be completed by the end of December. Several new staff positions have been filled, the sports season is progressing well, and the high school play this year will be *The Diary of Anne Frank*, scheduled for January.

Mr. Taylor (Beavercreek) – Popcorn Festival was well attended and that the sports season is going well. He shared that a renewal levy will be on the ballot in November. Upcoming events include Homecoming and the Faith Leaders Luncheon. He also noted that the preschool has opened with eight new classrooms.

Mr. McCoart (Fairborn) – Demolition of the last portion of the old building has been completed. The school year and fall sports season are going well. He noted that the elementary building is at capacity and discussions have begun regarding solutions. The music department has performed well in recent contests, Yondr pouches are still being utilized, and the district is working with GCCC on new satellite programs.

Mr. Leightenheimer (Xenia) – There are no current construction projects. The football season has started with a record of 2–1, and Harvest on Main will be held on October 11.

Mr. Remaly (Bellbrook) – Annual golf fundraiser will be held on September 27. He shared that the district received a STEM award, and a JROTC cadet recently earned their pilot's license. In addition, Bellbrook High School teacher Rob Schultz presented at the Annual AP Conference in Boston.

Mrs. Arthur (Greeneview) – School year is off to a strong start and the district has a new High School Principal. She reported that the high school football team is 1–2, middle school football is 2–0, and girls' soccer is 4–0. Construction of a new baseball dugout has been contracted out, and upcoming events include the Ram Pride Rally and the Fall Festival.

## Administrators:

<u>Georgia Lewis (Treasurer)</u> -- We have moved to a 24-pay schedule. The GAAP & Audit notice has been received for the end of October. Additional land has been purchased across the street from GCCC. Grant Contracts are being processed.

<u>David Deskins (Superintendent)</u> – The Advisory Breakfast is October 17<sup>th</sup>. The district has received a grant of \$500,000 from the Charlie L. Shore foundation for the updated welding lab.

<u>Adult Education –</u> The next Basic Police Academy started September 8<sup>th</sup>. We have 14 cadets in the academy. The 3-day audit is September 10<sup>th</sup>. We are hosting the GCLEA luncheon on September 18<sup>th</sup>. It will also serve as our advisory meeting. The 21-day audit for Corrections is scheduled for September 22nd. Corrections starts October 14<sup>th</sup> with the free mental health training on October 8<sup>th</sup>.
