Mr. McCoart (Fairborn) – reported that the groundbreaking for the new middle school took place on May 1st, with the school scheduled for completion in 2027. He also mentioned that the 2024-2025 school year finished strong.

Mrs. Gillaugh (Cedar Cliff) – Our PTO sponsored several wonderful events this year, raising \$11,000.00 through the dance-off fundraiser. The track team earned 5th place in the State for the 4x800 relay and 8th place in the 300m hurdles. Additionally, the baseball team were regional runners-up.

Mr. Leightenheimer (Xenia) – Dr. Simpson has been appointed as the new principal of Xenia Community Schools' middle school. The demolition of the old middle school has been completed, and plans are underway to construct a parking lot, bus loop, and ball fields at the site.

Mr. McQueen (Yellow Springs) – Building renovations have commenced this summer, with a focus on enhancing classroom spaces. All year-end events, including the Music Man musical, prom, and graduation, were successfully held.

Mr. Taylor (Beavercreek) – Over 20 staff members are retiring from Beavercreek Schools this year. The district was honored with the award for Best Community for Music Education. The baseball team advanced to the District Finals, the Men's Tennis Doubles team made it to State, and the Women's Track team secured 1st place in the 300-meter hurdles.

Mrs. Arthur (Greeneview) – A Greeneview teacher was honored with the Tropical Smoothie Award, selected from over 11,000 candidates, earning the district a \$1,000 smoothie party. Negotiations have been successfully completed. The baseball team claimed the OHC South championship, while the softball team finished in 3rd place. The year-end field day and awards ceremony were a success. Additionally, a new high school principal will be joining the district next year.
