Mr. McCoart (Fairborn) – Fall athletics have finished; Music concerts are starting; Construction on the middle school will start in February; They will be selling the Baker property after demolition is complete.

Mrs. Gillaugh (Cedar Cliff) – The OSBA Capital Conference was enjoyable; Fall concerts are taking place; The high school boys' cross-country team were the district champs this year. They placed 10th at state competition; The cheerleaders placed 3rd in the OHC cheerleading meet; Lauren Wiesert, Girls Tennis, was named Player of the Year by the OHC.

Mr. Leightenheimer (Xenia) – The football team did really well this year; Their high school cheerleaders won the Miami Valley competition; Strategic Planning is ongoing; Warner Middle School's move-in is scheduled for January.

Mr. Taylor (Beavercreek) – The bond issue failed; The Board Office will be moving December 1st; They received the Purple Star recognition on Monday, November 4th; Hosted a faith leaders meeting; The OSBA student fair was incredible. Many of the students are in Career Technical Education; They had an Open Book event to provide transparency in their curriculum; Their concert season is starting.

Mr. McQueen (Yellow Springs) – The renewal levy passed; The elementary school has a choir from Zimbabwe visiting; They held their first enlistment expo for high school students.

Mrs. Arthur (Greeneview) – The levy did not pass; They have plans to build a multi-purpose space with ESSER funds; The high school will perform the fall play "10 Ways to Survive the Holidays"; The Elementary Cowboy program is tomorrow; The high school girls soccer team are district champions; The football team will be playing their regional semi-final game this Friday at Fairborn.

Mr. Remaly (Bellbrook-Sugarcreek) – The district welcomed Amit Gautam as their new treasurer; The high school play will take place next weekend; Their fall sports had a good season, and are excited for winter sports.

Administrators:

<u>Georgia Lewis (Treasurer)</u> – Attended OASBO Leadership Conference; Audit is still ongoing with a projected completion date of early December; Collaboration with Curriculum and Satellite supervisors to go over next year's curriculum budget.

<u>Brian McKnight (Director)</u> – Staff evaluations are ongoing; Career Awareness Days December 4-6; Parent Teacher Conference Night was held November 7, had approximately 515 visitors for the night; Interview potential science teachers; Participated in BPA practice judging to help students prepare for state and national competitions; Created a GROW group for helping under-represented females; Veterans' Day Celebration was hosted for military students; On November 30, 27 students participated in Mock Interview Day.

Adult Education - The Corrections Academy started October 15th. They currently have 14 enrolled. They will graduate November 8th; They trained 10 Animal Welfare Officers in October; The Field Training Officer class is November 18 - 20th. There are 19 signed up; The Peace Officer Basic Training has 12 cadets in the September class. The next academy starts December 9th; Fairborn PD, Kettering PD, Middletown PD, Premier Health, Wilmington PD, and Miamisburg PD were here to recruit in October.

<u>David Deskins (Superintendent)</u> – The Christmas dinner will be December 11th; Additional property purchase discussions are ongoing; The Business Advisory Board met last week and discussed the topic "What Do We Do Next?" during the meeting 11 different options were presented to the members and they were given the opportunity to vote for their top choice. Popular ideas were building expansion, more adult education offerings, and partnering with local districts.
