1. Call to Order-

Mr. Bills called the meeting to order at 6:35pm.

2. Public Comment-

No speakers came forward during the public comment period.

3. E3 Awards-

4. Consent Agenda

5. Finance/Facilities

- 1. Finance Committee Report: Nothing significant to report. Mr. Nelson shared that the recent Chromebook devices purchases totaled approximately \$310k and delivery is expected for next week.
- 2. Construction Update: The admin building shell is complete and crane has moved out. The main lingering item is sewer issue, that Randolph County and Asheboro City have worked together to develop a solution for. The project is still currently on schedule. End of May to build this new sewer station to get our certificate of occupancy. Wheat met with construction regarding the interior of the building today. The sewer was the last major hurdle in terms of permits, and potential hiccups.
- 3. National Board Supplement: Met with the interest group lead by Mr. Tarlton. 11 total who are interested in the National board Supplement. We are looking at fully funding the National Board process for our teachers, created a memorandum of agreement and presented that to our committees.
 - 1. A Motion was made by Mr. Reid, seconded by Mr. Van Derveer, to approve the National Board Supplement, along with a 2-year agreement from the Teachers upon successful completion of the National Board components. All in favor. None opposed. Motion Carried.

6. Governance

- 1. Governance Committee Report: There were no updates.
- 2. Board Nominations Update: There are currently five applicants for upcoming 2023 Board Member interviews.

7. Academic Excellence

- 1. Academic Excellence Committee Report: Teacher Representatives from each school provided updates to the Board.
 - 1. Middle school is looking at standards by student and class, along with a vertical alignment component. 6th grade is piloting the NC Check-ins this year in Math and ELA, beyond using iReady. Beta Club Induction is upcoming, along with Special Olympics.

- 2. Elementary School hosted their Hispanic Heritage night and had a good turnout. Teachers visited the HS to prepare for upcoming move and began compiling inventory to prepare for deficits. Farm day is coming up next week FFA is coming, 4H, along with Drones in Farming.
- 3. High School Mr. Trogdon shared that things at the High School are going well. The recent Monster Night was a success and involved UCA orchestra, chorus, and dance (Wheat on Drums!) teams. Mr. Trogdon shared that fall sports have officially ended, with several teams earning a playoff bid.
- 2. Charter Renewal Update: Dr. Castelli shared that UCA was up for a 10-year Charter renewal, but UCA is currently low-performing so there has been more discussion with NCDPI. However, we are above our current cohort within Randolph County. Dr. Castelli sent documentation over to demonstrate our data. Voting will take place in January. Will be notified of designation as 7 or 10-year renewal in the spring. UCA does meet qualifications for 10-year renewal.

8. Other Business/New Business

Dr Castelli shared that she is working with admin and staff to outline smoother process for Called Meetings.
