Dear Parents and Students,

This letter is to inform you about a presentation covering the following academic programs that award college and high school credit:

- College Credit Plus (CCP)
- Advanced Placement (AP) courses
- Dual Enrollment CCP courses at NHS (currently College Comp I/II and General Chemistry)

On January 8, 2026, from 7:00 PM -8:00 PM, representatives from the local college CCP programs will be sharing information and answering questions regarding CCP. This session will also include a discussion on AP courses and the difference between AP and CCP. We will also discuss current courses offered at NHS as Dual Enrollment CCP courses. This session is recommended for all students currently in grades 6-11 who are considering taking College Credit Plus courses next school year.

**The meeting will be held via Zoom meeting and a link will be provided as we get closer to the event with additional information.**

This letter is being sent to all parents of students currently in grades 6-11. The state mandates that we notify ALL parents of the opportunity to participate in the College Credit Plus (CCP) programs.


The CCP program permits college-ready students, grades 7-12, who qualify for college admission, to receive state funding to participate. The bill establishes guidelines and procedures for enrolling 7-12 grade students in CCP programs. The postsecondary institutions to which this optional program applies are state-assisted colleges or universities. Legislation requires school districts to inform students and parents of this program on an annual basis. **Note: If you plan to participate in the CCP program for the 2025-2026 school year, parents and students should attend this meeting outlining the requirements for participation.** The meeting will outline program guidelines and responsibilities and will specify procedures to be followed. Following the meeting, students and parents will be responsible to search for appropriate colleges and meet all application deadlines.

**The CCP Intent to Participate and Student/Parent Acknowledgement forms must be returned to the High School Counseling Department on or before **March 27, 2026**.** Forms are posted on the CCP website (<https://www.nordoniaschools.org/CollegeCreditPlus>).
