Treasurer's Message Renewal Levy Important For Continued Financial Stability

The Marion City Schools Board of Education approved a fiveyear forecast at the May 17, 2021, Board meeting, which shows a positive ending balance at the end of five years if the current emergency levy is renewed.

As required by state law, all school districts must update their financial forecast each November and again in May.

The passage of an upcoming renewal levy will maintain current daily operations and will provide financial stability for our school

district at no additional cost to taxpayers.

This year had many surprises along the way, including receiving federal funds through the ESSER (Covid Relief acts) funds, state rebates of BWC payments, and a reinstatement of a portion of revenues lost

Four Pillars Update: Growth and Empowerment, Personal Ownership, and Collaboration



Marion City Schools developed its four pillars to support its vision of inspiring a community of achievement. The overarching goal of the four pillars is to provide every opportunity for every student to be successful in not only academics, but life skills as well. It is our hope that each child in each school is healthy, safe, engaged, supported, and challenged. In addition, we've incorporated the beliefs of empowerment and growth, personal ownership and collaboration, which are inherent to the success of each pillar.

Learning

For Learning, the goal is to meet the state standard on the local report card by working with the Ohio Improvement Process as well as reducing the number of discipline days in the district through a multi-tiered system of support for students. This summer. MCS is offering 17 different Enrichment camps to all students K-12. Whether you want to learn a new sport, become an artist, make some music, or challenge your brain, the 3-day camps offer students a variety of fun activities and learning experiences to choose from. Offering a combination of academics, enrichment, wellness, arts and more, there's something for all students.

Literacy

With Literacy, the district reading level has to meet the state standard. To accomplish this, MCS will align tier instruction with the "five big ideas of reading" as well as providing resources to the community to acquire necessary information, knowledge, and skills to support child literacy. Updates for this pillar include purchasing a new reading curriculum for middle school (StudySync by McGraw Hill), choosing two reading curriculums to pilot in the elementary schools for next year (Wonders by McGraw Hill and CKLA by Amplify), we have 28 staff members going through LETRS (Language Essentials for Teachers of Reading and Spelling) Units 5-8 training this summer and 35 going through Units 1-4. MCS is offereing a free Preschool Summer Literacy Camp at Garfield elementary for children ages 3-6. Children will enjoy playing while learning and developing skills in a literacy and language-rich environment with songs, fingerplays, stories, crafts, toys, and gross motor time. The activities will be playoriented and linked to the language and literacy Early Learning and Development Standards for the state of Ohio.

Leadership

Under the Leadership pillar, the goal is to reduce staff turnover and improve the open enrollment ratio by 10%. To accomplish this, the district is cultivating a culture of authenticity and inclusiveness and will be reading Above the Line by Urban Meyer this summer. Text was chosen to examine how leaders can sustain a culture of excellence for students, staff, and community members. MCS will also be completing the Focus 3 training this summer. Focus 3 training will allow our Leadership Pillar the opportunity to create a culture playbook to sustain our focus on creating a culture of excellence at Marion City Schools.

Legacy

With the Legacy pillar, the task at hand is to meet the state standard for the "Prepared for Success" component by improving structures, instruction, and opportunities. By doing so, this will prepare students to make the important decision of enrollment, enlistment, or employment. In the 2021 graduating class, 76 students had earned 2226 college credit hours with fourteen of those graduates already earning Associate Degrees from Marion Technical College. There were also 75 students that had earned more than 842 credentials with certificates from welding, auto, retail, CPR, and nursing. For next school year there are a host of new programs and activities as well that are sure to bolster the Legacy pillar's foundation. A New Industrial Maintenance Program has 80 students enrolled for next year and Harding is also bringing back the Career-Based Intervention program to be taught by new head basketball coach, Jamie Pearson. Three of our teachers will be receiving training for AP Biology, AP Computer Science A, and AP Computer Science Principles this summer and Harding High School will be a site for two ACT national test dates: June 12, 2021 & July 17.

Board Votes to Place Zero Tax Increase Renewal Levy on November Ballot

The Marion City Schools Board of Education approved a Resolution of Necessity to place a 5-year emergency levy on the November 2, 2021, ballot. Once the County Auditor's Office certifies that the request and millage amount is correct, the board plans to vote on a Resolution to Proceed during a June board of education meeting.

The levy, which was first passed in 1989, generates \$2 million in operating funds for the district. Since it is a renewal, it will not increase taxes. Operating levies fund the day-to-day operations of the district including teachers and staff, technology, supplies, maintenance, and utilities.
