#### **GEER II SNS**

- Federal Funds-Governor's Emergency Education Relief Fund (GEER)
- Period of availability-
  - October 1, 2023 through September 30, 2024
    - Obligated by September 30, 2024 and Liquidated by December 31, 2024 (DEW)
      - Liquidated by ESCCO-December 15, 2024 (invoices to the ESCCO by December 1, 2024)



# GEER II SNS (continued)

- State Education Agency (SEA) required to provide services to Non-Public Schools (NPS)
  - SEA is Ohio Department of Education & Workforce (DEW) for the State of Ohio
  - DEW contracting with Educational Service
     Centers (ESCs) in Ohio to provide the services on their behalf



# GEER II SNS (continued)

- Activities to be Performed by ESC through Agreement
  - ESCCO Performs Services under the control and supervision of DEW
    - The ESCCO has entered into Memoranda of Understanding with Northwest Ohio ESC and North Point ESC to manage NPS assigned to their ESCs by Ohio DEW.
  - ESCCO after consultation with Non-Public Schools (NPS) <u>will determine</u> the manner and method of providing services.





#### **ESCCO Process**

- ESCCO/DEW Agreement and MOUS with other ESCs commenced October 1, 2023
  - Services Provided must begin on this date or after
  - Goods/Equipment purchased must be after this date
- ESCCO invoices DEW and other ESCs where applicable for any of the above allowable expenditures
- Consultation with NPS
  - David Varda
  - Kevin Scott (staffing)
  - Christy George (purchasing and contracted services)
    - Review approve application to determines needs
- ESCCO will create a page on the website:
  - www.escco.org/EANS
  - Resources such as forms, DEW and USDOE guidelines, etc.





## ESCCO Process (continued)

- Services-Instructional or otherwise
- ESCCO contract with service providers
  - Service Providers currently working with NPS would be eligible but would need to contract with ESCCO
- ESCCO to employ personnel to meet need
  - ESCCO will consider individuals identified by NPS
    - Any individual employed by the ESCCO would have to meet onboarding requirements
      - » Licensure
      - » Background Check-FBI/BCI
      - » Other employment onboarding requirements





## ESCCO Process (continued)

- Goods or Products
  - ESCCO Purchasing Procedures
    - Governed by Ohio Revised Code
      - Governing Board Policies and Administrative Regulations/Procedures
        - Purchases \$50,000 and above (two or more quotes required)
