

**COVID-19 Pandemic Relief Funding**  
**Local Use of Funds by Anthony Wayne Local Schools**

The [American Rescue Plan Elementary and Secondary School Emergency Relief \(ARP ESSER\) Fund](#) was enacted as a part of the American Rescue Plan and provides nearly \$122 billion to states and school districts nationwide.

These funds were made available for limited use by Local Education Agencies (LEA) to address the safe reopening and operation of schools, and to address learning loss as a result of the coronavirus pandemic. The federal guidelines addressing the allowable uses for these funds are available on the [Ohio Department of Education website](#).

Any school receiving funding was required to submit a *Safe Return to In-Person Instruction and Continuity of Services Plan* prior to the 2021-22 school year. Anthony Wayne Local Schools [Safe Return of In-Person Instruction and Continuity of Service Plan \(August 2021\)](#) is available on the district website.

The Anthony Wayne Local Schools district was *awarded* nearly \$4.9 million through ARP ESSER. As of January 10, 2023 the district has received \$2,655,401.66 for costs associated with the programs, staffing and supplies necessary to provide a safe learning environment and offer instructional support. *All related expenditures will continue to be submitted to the state for review and reimbursement on a semi-monthly basis until funds are exhausted or the discontinuation of the program.*

These funds were used as intended to ensure the safe return of students to the classroom and support student learning in the following ways:

- Technology associated with one-to-one student/device use
- Extended learning and enrichment activities, transportation, and food service related to learning loss recovery
- Employment of a required district COVID-19 Liaison for pandemic mitigation and monitoring
- Employment of short-term contract teachers to support instruction and provide interventions for students
- Employment of short-term contract instructional coaches to support instruction and interventions for students
- Employment of intervention specialists and paraprofessionals to support student learning
- Salary and benefits for district nurses
- Transportation support for students experiencing homelessness
- Health, safety, and other supplies and materials
