# Voters to decide on \$13.6 million proposed budget, board election

Budget adds opportunities for students, remains below tax levy limit

On Tuesday, May 20, 2025, Worcester Central School voters will decide on a \$13,607,856 budget proposal for the 2025-26 school year. The proposed budget maintains all current academic and extracurricular programming for students, and adds BOCES services, a school resource officer as well as a teaching position to accommodate growth. The proposed budget is a 6.4% spending increase compared to last year and includes a proposed 2.47% tax levy increase that is lower than the calculated allowable tax levy limit of 2.49%.

In addition, the proposed budget includes the purchase of two diesel powered school buses to maintain the five year bus replacement schedule established years ago by the Board of Education. This ensures our fleet maintains newly enhanced safety features and minimizes repair costs for maintaining buses and vehicles past their practical life.

"We are excited for the next school year and appreciate the investment our community makes in our students", said Superintendent Tim Gonzales. "Our board of education is working hard for our students to meet success, while being aware of the impact on taxpayers."

Voters will also elect one candidate to the board of education.

# Questions & Answers about the Proposed Budget

#### Q: What additions are in the budget?

- A: The 2025-26 budget proposes the purchase of 2 diesel powered buses and the addition of a school resource officer to enhance security on campus. This year's proposed budget has additional BOCES services for English as a new language learners and assistance for students with disabilities.
- Q: Is the proposed budget within the district's tax levy limit?
- A: The proposed 2025-26 tax levy increase is 2.47%, which increases the budget \$93,694, and is under the 2.49% tax cap as calculated by the required state formula.

#### Q: Why is the "2% tax cap" not really 2%?

A: The "2% tax cap" is actually different for every school in the state and is determined by NYS law through a formula using each school's unique fiscal data. Tax levy limits vary by district every year. For the 2025-26 school year the WCS tax levy limit is 2.49%. The calculated amount is a threshold that determines what level of voter support is needed to pass a budget. If a district's tax levy increase is below or equal to the limit, a simple majority (50 percent plus one vote) is needed. If a district's tax levy increase exceeds the limit, 60 percent voter approval is required.









# Budget Vote Information

## What will I be voting on?

- A \$13,607,856 budget proposal for 2025-26.
- One school board seat. (See page 3.)

## When and where do I vote?

Tuesday, May 20, 2025, from 12-8 p.m. at the Worcester CSD Library.

## Who is eligible to vote?

District residents who are U.S. citizens, 18 years old or older and residents in the school district for at least 30 days prior to the vote; and are not otherwise disqualified under the Education Law

## How can I vote by absentee ballot or mail ballot?

An application may be requested from the district clerk Wendy Elliott by phone at (607) 397-8785 or in-person at the district office, 198 Main St., Worcester, NY 12197.

Absentee ballots are available by application from the district clerk for qualified voters unable to vote on the day of the referendum.

A qualified voter may apply for an early mail ballot on your own behalf by application from the district clerk.

Completed applications for an absentee ballot or completed applications for an early mail ballot must be received by the district clerk at least seven days before the election, if the ballot is to be mailed to the absentee voter or mailed to the early mail voter, or the day before the election, if the ballot is to be delivered personally to the absentee voter or delivered personally to the early mail voter.

# All ballots are due by 5 p.m. on May 20.

# WHAT IF THE BUDGET VOTE FAILS?

The board of education can adopt a contingent budget which would prevent WCSD from increasing the current levy by any amount.

To make up the levy difference of \$93,694 incurred with a contingency budget, WCSD could possibly cut program expenses or increase the amount we would have to take from our fund balance.

Alternatively, the district may choose to hold a re-vote on June 17, 2025.
