BEHIND-THE-WHEEL TRAINING AGREEMENT FOR ONLINE STUDENTS - TEEN CLASS D LICENSE COURSE

This agreement constitutes the entire contract between the school and student, and any verbal assurances or promises not contained herein are not binding on either the student or the school.

*The emergency medical contact form on file with **MOV ESC Driving School** will be used in case of an emergency.

*Students will be contacted through school email accounts.

MOV ESC Driving School, referred to as the driving school, agrees to provide the applicant, referred to as the student, the 24 hours of classroom instruction and the minimum of 8 hours of behind-the-wheel training based on the Ohio Driver Training Curriculum. The student will complete the 24 hours of required classroom instruction through Aceable, an Ohio approved online provider. MOV ESC Driving School will provide students with an account voucher for the online course. Before a student can begin the 8 hours of behind the wheel training, he must complete the online course and receive a Certificate Completion. The student will give the original copy of the Certificate of Completion to the Driver Education School Site Coordinator.

MOV ESC Driving School will furnish a licensed instructor and a motor vehicle for the behind-the-wheel instruction. It is strongly advised that a student complete a minimum of three additional hours per week of driving practice. It is through repeated practice that the skill is developed and perfected.

When all training is completed and paperwork is submitted to the Driver Education School Site Coordinator, MOV ESC Driving School will provide an Ohio Department of Public Safety (ODPS) Certificate of Completion of an Authorized Course of Driver Training. The student will take this certificate to the BMV when they take their driving test.

Tuition for the driver's training program (online classroom training and the behind-the-wheel instruction) is \$350.00. A deposit of \$100.00 is required to begin. **All tuition must be paid before an ODPS Certificate of Completion is issued.** The online portion of the driver's training course must be completed within **six (6) months of the start date**; for this contract that would be: _____ (for office use).

MOV ESC Driving School

The student must have a valid Ohio Temporary Learner's Permit and a Certificate of Completion to schedule the behind-the-wheel lessons. Behind-the-wheel instruction will be scheduled in two-hour sessions. The student must bring their Ohio Temporary Learner's Permit and required glasses or contacts to the behind-the-wheel driving appointment. Students may be charged a rate of \$25.00 for any appointment he/she does not meet, unless the school is given 24 hours of notice.

The school will give reasonable notice for delays caused by unsafe driving conditions, mechanical failures or any other reason over which it has no control. Behind-the-wheel instruction will be conducted in the counties relevant to the School Districts participating in the MOV ESC Driving School. We reserve the right to limit our service area. On most drives, students will be start from the MOV ESC Driving High School Site and dropped off at the address provided on the application or at the original pick-up location. No exceptions will be made unless mutually agreed upon by the Driver School personnel, parents of the student and school administrator of designee.

MOV ESC Driving School reserves the right to cancel this agreement at any time should the student's conduct indicate a lack of responsibility deemed necessary to safely operate a motor vehicle in the opinion of the teacher. Students suspended from school will not be allowed to drive during the suspended period. Proper attire must be worn at all times. Improper language will not be tolerated in the vehicle or any other time. No food in the vehicle. Soft drinks or water is allowable if the container has a lid. Cell phones will be silenced and put in purse or backpack in the back seat. No smoking. Provide 24 hours' notice if you need to cancel or reschedule your driving lesson. Once you begin the online classroom training no refund will be given for that portion of the training. Should this agreement be cancelled, BTW fees will be pro-rated, and an appropriate refund might be given. **Students are not permitted to drive if he/she is absent or suspended from school.**

Any additional in-car training may be obtained at the hourly rate of \$25.00 per hour. If applicable, the student may for an additional charge of \$90.00, hire the instructor and use the driving school's vehicle to take a driving exam at a State exam center located in their city/county of residency.

By law, a driving school cannot guarantee the issuance of a driver's license to the student. It should be emphasized that successful completion of the behind-the-wheel course does not and should not imply that the student is an accomplished driver. Your continued work with your son/daughter is essential to further develop strong driving skills. It is mandatory that you provide your child with a minimum of 50 hours of additional supervised behind-the-wheel driving.

The parent or guardian, or the person having custody, and the student, shall be jointly liable to the agreement. Driver training is licensed by the Ohio Department of Public Safety through the Driver Training Program, 1970 W. Broad St. Columbus, OH 43223.

[Name of Enterprise], hereinafter referred to as "The Driving School" agrees to provide applicant, hereinafter referred to as "Student", 8 hours of behind-the-wheel training based on the Ohio Driver Training Curriculum. The student will complete the 24 hour equivalent of required classroom with an Ohio approved online provider. The student must provide a certificate of completion from an approved online driver education program to begin the eight hours of behind-the-wheel training. State of Ohio regulations require all training be made available by _____. Should a student be unable to attend available training sessions offered, the school is relieved of the aforementioned obligation. The Driving School shall furnish a licensed instructor and a motor vehicle for instruction. The tuition for said instruction is \$350.00.

Any additional in-car training may be obtained at the hourly rate of \$25.00 per hour. If applicable, the Student may, for an additional fee of \$90.00, use the Driving School's vehicle to take a driving exam at a State exam center located in any nearby _____ County, OH.

The Student is required to obtain a valid temporary driving permit and pay tuition in full prior to scheduling the practical driving portion of the training. If the student must cancel a scheduled driving appointment, cancellation must be made a minimum of 24 hours prior to the scheduled appointment. Failure to do so may result in an additional fee of \$350.00. The same fee shall apply should the Student fail to appear for, or for any reason not prepared to take, the scheduled lesson. Should a check received as payment of tuition in whole or in part, be returned due to insufficient funds, the Student may be removed from the driving schedule until such a check is made good. An additional fee may be charged for any returned check.

The student is required to complete all available training within six months of the date the training begins. Upon expiration of this agreement, a reinstatement fee may be charged before any further services are provided. The Driving School does not guarantee the issuance of a driver license to the Student. If training is not completed within the six months, a new agreement shall be established and training shall be restarted.

The Driving School reserves the right to cancel this agreement at any time, should the Student's conduct indicate a lack of responsibility deemed necessary by The Driving School to safely operate a motor vehicle. Destruction of property, or the possession, distribution, or use of any tobacco product, alcohol, or drug of abuse is strictly prohibited. Should this agreement be cancelled under such circumstances, all fees may be pro-rated, based upon hours of service provided prior to cancellation.

Refund Policy: Students are only refunded for the portion of the program that was not completed.

The Driving School shall furnish a certificate of completion to all students under the age of eighteen years, who successfully complete the course. Completion, as defined by the State of Ohio, refers to the completion of the required number of hours online and the student's good-faith effort having been exercised during the practical driving portion.

Commercial Driving schools are licensed by the Department of Public Safety through the Driver Training Program Office, 1970 West Broad Street, Columbus, Ohio 43223. Valuable information for parents and teenagers is available on the internet at www.drivertraining.ohio.gov, under Parents and Teens.
