As a ticket holder, I understand and agree to the foregoing and agree to abide by the following rules of the Straight from the Heart Raffle:

- All mail-in entries must be postmarked by February 19, 2024 and received by February 21, 2024 to be counted in the raffle.
- There will be 4 early bird drawings to win \$1000. Entries must be received by 11:59 p.m. the day prior to the early bird raffle drawing. The early bird drawing dates are: November 20, 2023, December 20, 2023, January 20, 2024 and February 20, 2024.
- Early bird winners will also be eligible for all prizes, including the \$100,000 Grand Prize to be drawn on February 24, 2024.

- Entries are \$100 each or 3 for \$200 and can be purchased online at HeartRaffle.org.
