## Teacher Aide

The successful candidate must be able to establish good relationships with children and others; have familiarity with classroom routines; have above average clerical aptitude; and be in good physical condition. They will be responsible for, but not limited to: assisting students with behavioral/management needs; assisting in physical care tasks and health related activities as appropriate; supervising students under the direction of classroom teachers and/or other professional staff.
