## *Middle School Special Education Teacher*

One (1) full-time position located at OAOC in Milford and one (1) full-time position at NCOC in Grand Gorge. These are 10-month, Teacher Unit, probationary positions.

## *Qualifications and Responsibilities*

Current NYS Special Education 7-12 or 5-9 certification is required. Experience working with middle/high school students with social emotional needs is preferred.

The Trust program is a service-intensive model for students with severe behavioral and/or social and emotional difficulties. It provides a highly structured learning environment and intensive behavior management strategies. Academics are tailored to individual learning abilities and styles, which also follow New York State Common-Core Learning Standards. Students are provided intensive IEP counseling and crisis support, as well as related services per their IEP. This program provides a safe, supportive, and accepting space for students with behavioral or emotional needs to explore appropriate socialization and coping skills as they learn and grow.
