### Qualifications and Responsibilities

Applicants must possess or be eligible for a NYS Career and Technical Education (CTE) certification. High school diploma or equivalent with a minimum of four (4) years of paid occupational experience or an associate's degree or higher in a related field with a minimum of two (2) years' paid experience required. Applicants must be able to provide proof of paid occupational experience. NYSED fingerprint clearance required.

Prior teaching experience is preferred but not required.
