## ***Teacher Aide***

## ***Qualifications and Responsibilities***

Graduation from high school or possession of a high school equivalency diploma required. The successful candidate must be able to establish good relationships with children and others; have familiarity with classroom routines; have above average clerical aptitude; and be in good physical condition. The chosen applicant must be able to perform all essential job functions, with or without accommodations, including performing physical restraints, as necessary, in accordance with TCI training. They will be responsible for, but not limited to: assisting students with behavioral/management needs; assisting in physical care tasks and health related activities as appropriate; supervising students under the direction of classroom teachers and/or other professional staff.
