Community Engagement was done throughout the planning process at the end of the 20-21 school year for the LCAP, LCP and ELO. In addition to providing input while drafting these plans, parents have had the opportunity to provide input, feedback and choice in preparation for the opening of the 21-22 school year in the form of surveys, and virtual meetings. A survey was sent to families (including SPED and EL families) on September 28, 2021, asking for input on various suggestions of actions/services to be funded with ESSER money. Input from this survey was taken into account as the ESSER plans were written.

Student input was taken from their annual student survey done for the LCAP measuring academic social needs, those results were reviewed and considered as decisions on actions/services were made using ESSER III funds.

Staff discussions including Teachers (General Education and SPED), Administrators, and classified staff were held during regular professional development and weekly scheduled meetings to ascertain the needs and concerns of staff about the academic and social/emotional needs of students.

Community and Staff were able to provide input in the development of the ESSER III plan (described above) and through open forum virtual meetings held through out the first half of the school year (August - November 2021) planning for various plans, situations and needs of our school community.

The LCAP Advisory Committee met on October 21, 2021 to review this plan for the ESSER III funds to provide input and suggestions for the use of these monies to meet the needs of the students and staff of STEAM Academy.

The ESSER III Expenditure Plan was taken to the River Islands Academies Governing Board for approval on October 26, 2021.

STEAM Academy does not have a Local Bargaining Unit, Tribes, Civil Rights Organizations or Underserved student group Advocates to consult with.

A description of how the development of the plan was influenced by community input.

Throughout the process of developing the LCAP, LCP and ELO plans for the 21-22 school year community input was given, and a summer bridge program was developed to extend the learning opportunities for the most at risk students to attend. The input received from our stakeholders influenced this decision based on expressed concerns about learning loss due to COVID 19. More Instructional Aides were added for the 21-22 school year to address learning loss needs and to help with class size. The concerns about safe environments was also heard from the community and this is reflected in the increase of staff to attempt to spread students out more across the school campus during non-learning times throughout the day (recess, lunch etc). The survey sent out to families in September allowed us to gather input to prioritize the use of the ESSER funds in this plan.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.
