



CCP Overview

- Program for students in grades 7-12
- Students earn college credit and high school credit at the same time



- No cost to the student for college tuition and books*
- Students can choose any college course that applies to a degree/certificate program (excluding remedial, private instruction, physical education, study abroad and religious courses)

*Dependent upon funding approval from the Ohio Department of Education





CCP Benefits

- Earn college credit for free
- Take classes in summer, fall and/or spring semesters (30 credits maximum per year)



- CCP courses are weighted the same as AP or IB courses
- Each college course of three or more credits counts as a yearlong high school course
- Large selection of courses
- · Advanced, challenging and rewarding environment

Why choose CCP at Tri-C°?

- Convenient locations
- Various teaching formats in-person, hybrid, online (synchronus) and asynchronus) and at participating high schools
- · Class time options morning, afternoon, evening and weekend
- Student services include counseling, tutoring, career center, transfer center, RTA U-Pass
- Earn an Associate of Arts degree while completing your high school diploma
- Experienced Tri-C coordinators and counselors work closely with CCP families





Possible Challenges for CCP Students

- · Courses can be rigorous and fast-paced
- Underperforming students
 - Failure or withdrawal from course may result in cost of tuition/books shifting to student/parent
 - Grades become part of the permanent record and appear on both high school and college transcripts
- Coordination of participation in high school athletics/activities
- College environment and course subject material







Student Accessibility Services and Disability Services

- Services are based on documented disability
- Students on an IEP or 504 plan may be eligible for accommodations
- Contact the Student Accessibility Services office early to make an appointment

Family Rights and Privacy Act (FERPA) protects the privacy of student records

 Complete FERPA release form to grant permission for access to student records





Getting Started as a CCP Student

(Preferred Tri-C deadline: April 15)

- Intent to Participate form due by April 1 to high school counselor (required by the state)
- Complete online Tri-C CCP application and CCP Mature Content permission slip
- Submit transcript or qualifying ACT/SAT test scores to determine eligibility
 - Depending on GPA and grade level, Tri-C placement test may be required





CCP Registration Process

- Receive decision letter and registration instructions via email
- Submit Mature Content questionnaire
- Meet with school guidance counselor to discuss courses you will take
- · Submit Tri-C's authorization to attend form
- Meet with Tri-C Counselor to choose courses that will fulfill degree requirements
- Register for courses
- Attend a College Credit Plus Orientation





Private school and home school students

- Intent to Participate form due by April 1 to ODE
- Student must apply for funding to ODE by the deadline.
 Request must include college acceptance letter.
- May receive a credit toward books with MOU

 - CCP allows a qualified 7-12th grade student to take college classes while still in high school
 - Level 1 courses
 - Lead to certificates and/or associate degrees
 - Examples: Associate of Arts, Associate of Science, and University of Cincinnati pathway, technical pathways
- What is Learn to Earn?
 - · Earn industry credential and pathway to graduation
 - Partnerships with employers that offer mentoring, job shadowing, tuition reimbursement, and employment opportunities
- Where can you take classes?
 - On college campus
 - Online
 - High School
 - Combination of all of the above modalities

Admission Requirements

Preferred requirements for all applicants:

- 3.00 cumulative GPA (required by the state)
- ACT or SAT scores are optional for 2021-22
- Applicants who do not take the ACT or SAT will be required to complete placement testing through the University.



How to Apply

- Complete the Online Undergraduate Application
- Submit official high school transcripts
- Print and Submit the CCP Signature Page which requires a student, parent & counselor signature
- Submit ACT or SAT scores (optional)
- The application deadline for the summer and fall semesters is April 15
- The spring semester deadline is October 15

Students applying to enroll at the Akron Campus or in distance learning classes must apply to the Akron Campus.

Students applying to enroll at Wayne College or UA Medina must apply to the Wayne campus.

College Credit Plus Updates for 2021-2022



- Returning applicants will no longer need to reapply to participate in CCP
- New Student Application Deadlines 2021-2022
 - Summer 2022 April 15
 - Fall 2022 June 1
 - Spring 2023 October 15
- CCP Eligibility
 - Student must have one of the following:
 - Qualifying ACT, SAT, or Accuplacer score
 - (or) an unweighted GPA of 3.0 or higher



College Credit Plus is Ohio's dual credit program

Students can earn high school and college credit at the same time Students enroll in college courses and adhere to the policies and requirements of the college







Students in Grades 7 through 12:

- Must be Ohio residents and
 - Attend an Ohio secondary school (public or private) or
 - Receive homeschooling instruction

Students in Grades 7 through 12:

- Must complete an assessment exam and be determined "eligible" based on exam scores for College Credit Plus
- *NOTE: Additional options for "eligible" determination are being considered, but will not be finalized until spring of 2022*

What is College Credit Plus

Students in Grades 7 through 12:

- Must successfully complete the courses in order to earn the credit
 - Even if a student fails or withdraws from the course, the college transcript and high school transcript will reflect the student's final grade
 - The high school transcript will match the college transcript with the course grade







What is College Credit Plus

Students in Grades 7 through 12:

- May take classes during the summer, fall, & spring semesters
- May take courses at the high school*, college campus, or online

*The option to take courses at the high school is only available if the high school has partnered with a college or university to offer college courses at the high school







How Can Students Participate?

Step 1: Eligibility

Students must be "eligible" for College Credit Plus participation based on assessment exam scores









How Can Students Participate?

- Students' scores on College Readiness Assessments must show that they are ready for "college-level" courses in at least one subtes on an exam
- Exams include ACT, SAT, Accuplacer, ALEKS, PlaceU, or MapleSoft
 - After a student applies to a college, the college/university will notify
 the student about exam requirements

How Can Students Participate?

Step 2: College Admission

- Students must apply for admission
- Students must meet admission requirements of the college
- Students must complete a "Permission Slip" that will be provided to the students with the college's application for admission.









Step 3: Course Registration

- If the student is considered eligible and has been admitted to the college, then:
 - The college will discuss course options with the student, based on assessment scores, prerequisites, and other requirements









Course Eligibility Rules

Students must complete their first 15 credits in Level I courses, which include:

- Transferable courses
- Courses in IT, Computer Science, Anatomy & Physiology, foreign language
- Courses that are part of a technical certificate
- Courses that are part of a 15- or 30-credit pathway

Course Eligibility Rules

Non-allowable courses include:

- Private applied courses with one-on-one instruction (such as performing art lessons)
- Courses with high fees
- Study abroad courses
- Physical education courses
- Pass/Fail graded courses
- Remedial courses or sectarian/religious courses









Other Requirements

Grades

- College Credit Plus grades earned in the college course is the same grade that will I
 on the high school transcript
- CCP course grades will be factored into the high school and college GPAs

Grade Weighting

 If a high school uses a weighted grading scale for Advanced Placement, International Baccalaureate, or Honors courses in a subject area:

Then College Credit Plus courses in the subject area will be weighted using the same
 scale in order to calculate the student's grade point average and class rank

How Many Classes Can a Student Take?

- Students may be enrolled in up to 30 credits per year, which includes high school courses:
- Calculation:
 - 30 (secondary school units x 3) = max CCP credits
- •The maximum number of credits allowable for a student while participating in the program is 120









Tests

 High School: Tests are sometimes given weekly or at the end of the chapter

 College: Tests are generally fewer in number and cover more material









Study Time

- High School: Required homework ranges between 1 to 3 hours per day
- College: Standard rule of 2 to 3 hours of homework for every hour spent in class (3 to 5 hours per day)









Knowledge Acquisition

- High School: Information provided mostly in-class. Out-of-class research is minimal
- College: Coursework will generally require more independent thinking, longer writing assignments, and out-of-class research









Grades

- High School: Numerous quizzes, tests, and homework assignments
- College: Few tests and fewer, if any, homework assignments will be used to determine final grades









Role of Parents

- High School: Parents are strong advocates working closely with teachers and counselors
- College: Parent serves as a mentor and support for the student; the college views the student as independent decision-maker
- College: The Family Education Rights and Privacy Act (FERPA) protects student education records









Accommodations

- High School: Parents and students work with high school staff to determine what assistance or accommodations can be made for students with IEPs or 504 plans.
- College: Students must work directly with college staff to determine if accommodations are needed. IEPs and 504 plans may or may not be included in the discussions.









Benefits of CCP

Students can:

- Earn high school and college credits at the same time
- Get a "head start" on career planning and degree or certificate completion
- Experience college early to understand the expectations of college life
- Save tuition and textbook costs









Benefits of CCP

Students can:

- Earn high school and college credits at the same time
- Get a "head start" on career planning and degree or certificate completion
- Experience college early to understand the expectations of college life
- Save tuition and textbook costs









What Happens if the Student Underperforms?

- If students do not earn a passing grade or if they withdraw too late from college courses, the district may require students/ families* to reimburse the tuition that the district had paid
- The grades that students earn will be on the students' college transcripts permanently

*If a student is considered "economically disadvantaged," a school may not seek reimbursement









What Happens if the Student Underperforms?

- If students fail or withdraw often, future financial aid may be also impacted negatively
 - For more information, contact the college's financial aid office for details
- If students perform poorly, they may be placed CCP Probation,
 CCP Dismissal or on academic probation or dismissal by the college

College Credit Plus Probation

A student will be placed on CCP probation if he or she earns less than a cumulative 2.0 GPA in CCP courses or withdraws from 2 or more courses in one academic term









While on CCP Probation, the student:

- May only enroll in one College Credit Plus course for one college term (semester or quarter)
- May not enroll in a college course in the same subject in which student previously earned D, F, NC grade (or equivalent grade)









CCP Dismissal

- If students on CCP probation do not increase their CCP GPA to a 2.0 or above during the probation term, they will be placed on CCP Dismissal
- While on CCP Dismissal, students may not enroll in any College Credit Plus courses
- A student can request (appeal) to be reinstated in the program









CCP Probation & Dismissal Appeals

 CCP Probation: Student may appeal to take a course in the same subject in which he or she previously earned a D, F, or received no credit









CCP Probation & Dismissal Appeals

CCP Dismissal: Within 5 days of being dismissed, the student may submit an appeal to the secondary school to appeal CCP Dismissal the student may appeal at the end of the CCP Dismissal semester

Each school must have a policy describing the process for appeals









- At public colleges or universities, there will be no cost to the students/families for tuition, required fees, and books
- Some optional expenses are the responsibility of the student/ family (Examples: Parking and transportation)

What Support Services are There for CCP

- High school counselors continue to provide assistance to all College Credit Plus students
- College advisors provide course selection assistance
- Colleges must provide the same academic supports to College Credit Plus students such as tutoring, library access, advising/counseling









Athletic Eligibility

Student athletes should:

- Learn the Ohio High School Athletic Association (OHSAA) requirements
- Know that summer term CCP courses cannot be used to bring a student into compliance with the OHSAA requirements for interscholastic athletic participation









Will the Credits Transfer?

- Certain general education and technical courses will transfer especially from one Ohio public college to another Ohio public college
- Students must check with colleges to confirm transferability
- Students should also visit https://transfercredit.ohio.gov for transfer information









Being "college-ready" is more than just being academically ready

- Consider emotional and social transition and college expectations
- Consider time management and organizational skills









Being "college-ready" is more than just being academically ready

- Grades earned in a CCP course are for high school AND college creand will be calculated into the student's GPA at both places
- College Credit Plus credits will be utilized in the calculation of

financial aid (after high school)

College Credit Steps to Take

This information is for those students interested in pursuing participation in the College Credit Plus program for the 2022-2023 school year. Below is a list of the next steps you should take in the application process for the program. Students/parents are responsible for the entire application process; the school does not initiate this process for you.

- Begin to identify institutions you are interested in applying to (previous students have attended Cleveland State University, Cuyahoga Community College, Kent State University or the Kent State University Twinsburg campus and the University of Akron--these are just examples for you).
- Locate the college's College Credit Plus application (some are the same as the undergraduate application and typically online at the college's website under Admissions) and selection criteria.
- Know the college deadline and submit your application to the college before the application deadline (this will differ by college).
- Submit the <u>Letter of Intent, Student/Parent Acknowledgement and Transcript Request forms</u> (included in this packet), to the High School Counseling Office no later than April 29, 2022.
- 5) Register for the ACT or SAT exam. The earlier you complete this exam the better. You can register at www.actstudent.org/regist/ or www.sat.collegeboard.org/register. Registration deadlines and test dates can be found on each website.
- 6) Meet with your child's school counselor if you have any questions or reservations about participating in the program to gain additional insight.

7) Be sure you schedule as though you will be attending school (Nordonia) full-time next year during the high school scheduling process. Your schedule will be changed after we receive confirmation of your acceptance and college courses selected.

Before school starts

You must **always** keep your school counselor informed of any changes to your College Credit Plus plan and details. It is <u>your</u> responsibility to make sure the school counselor has details of these changes, the college will not communicate these to the high school:

- courses added to your schedule
- courses dropped
- grades (student should print copy and bring to counselor as soon as they are reported even though college will send official transcript after semester ends)

Remember: Additions, withdrawals or failures in CCP classes may have academic and financial implications and may also impact high school graduation.

- Application/Enrollment Process: receive recommendations from current teachers, check AP Potential results from PSAT in your College Board account. Submit AP course requests during scheduling.
- All students enrolled in an AP course are required to take an the AP exam in May.
 Current cost is approximately \$94 per exam.
