

WEST MIFFLIN AREA HIGH SCHOOL STUDENT PARKING PERMIT RULES & REGULATIONS

For mutual protection of persons and property, we agree that the driver will abide by the driving rules and regulations of the Pennsylvania Vehicle Code, and the West Mifflin Area School District, including those listed below:

- ONLY 11th and 12th grade students are permitted to park on campus.
- Only students with a valid PA Drivers License will be permitted to park on campus.
- Parking Permits may be issued to students demonstrating a legitimate need to park on campus. The determination of such legitimate need will be determined by Administration
- Parking permits **WILL NOT** be issued until all debts/obligations have been satisfied
- Students are required to pay a non-refundable application fee of \$50.00 (CASH ONLY)
- Students must present the following valid documents at the time of application, and shall maintain their valid status during the entire parking permit period:
 - PA Operator's License
 - Vehicle Registration certificate for any vehicle or vehicles to be parked on campus
 - Insurance identification card for any vehicle or vehicles to be parked on campus
- The parking permit shall be displayed on the rearview mirror of any properly registered vehicle, while on school grounds.
- Students shall only park in their issued parking spaces. A warning notice will be issued for the first offense. Subsequent offenses will result in a citation and/or towing of the vehicle and the student may be subject to other school disciplinary action
- Lost or stolen parking permits shall be reported to the School Police immediately
- Replacement permits may be purchased for an additional non-refundable fee of \$10.00
- Parking Permits shall be returned to the School Police Office at the end of the school year or whenever parking/driving privileges are suspended or revoked.
- Students shall operate approved vehicles in accordance with all Pennsylvania laws and are subject to penalties for any violation.
- Students must park in the designated student section by tag number. During normal school hours. The student section is clearly marked by green lines.
- All drivers shall register their passengers on the approved passenger list, which is included in the parking permit packet. Please refer to the "Passenger Restrictions" section for further information

STUDENT PARKING PERMIT RULES & REGULATIONS

Parking permits WILL be revoked for the following reasons:

- Suspension/Revocation of privileges will only begin after the permit tag has been returned to the WMASD Police.
- Sharing parking permits with other students
- After the third illegal tardy in one semester
- **After the third un-excused absence in the 2026/2027 School year**
- Failure to maintain passing grades in all classes
- Leaving school without permission
- A second offense for parking outside of an assigned space/area
- A second offense for failure to display a parking permit
- Any forgery or alteration of a parking permit
- For violating school rules
- Unauthorized passengers
- Unauthorized entry into a car during school hours (including lunch periods)
- Driving in a manner that is dangerous to oneself or others on school property
- Violations of Pennsylvania laws
- Administrative discretion/School Obligations

ALL VEHICLES ARE SUBJECT TO SEARCH WHILE ON SCHOOL PROPERTY IN ACCORDANCE WITH SCHOOL BOARD POLICY No. 226.2, which is included in the parking permit packet.

School Officials are authorized to search a student's personal possessions or vehicle parked or operated on school property when there is reasonable suspicion that to believe that illegal, unauthorized contraband, or otherwise prohibited materials are contained inside of, or in the event such materials are in plain view upon inspection of the vehicle's exterior. Such searches may include all compartments of vehicle.

Student drivers are subject to all Pennsylvania laws and may receive fines and/or towing for violations while on school property.

Passenger Restrictions: PA Vehicle Code 1503 (c)(2.1) Junior Driver's License:

For the first six months, a junior driver shall not drive a vehicle with more than **ONE** passenger under 18 years of age, who is not a member of the junior driver's immediate family, unless the junior driver is accompanied by a **parent or legal guardian**. After expiration of the first six months, a junior driver shall not drive a vehicle with more than **THREE** passengers under 18 years of age, unless the junior driver is accompanied by a **parent or legal guardian**.

For the purposes of the above paragraph, a junior driver's immediate family shall include only:

1. Brothers
2. Sisters
3. Step Brothers
4. Step Sisters
5. Adopted or Foster children residing in the same household as the junior driver.
